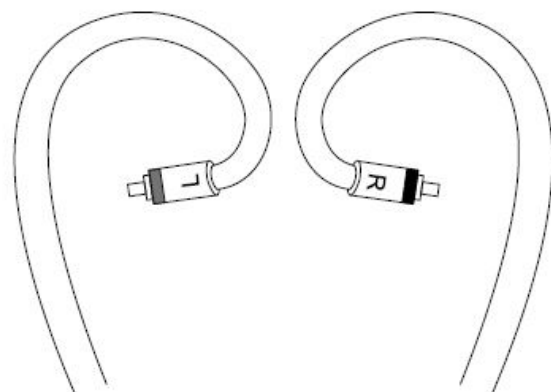
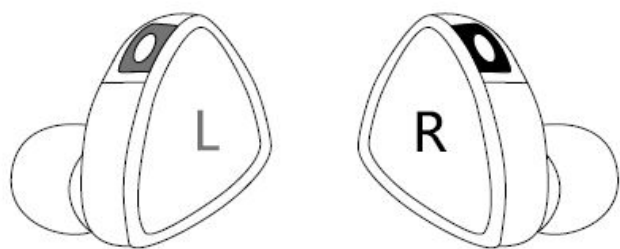

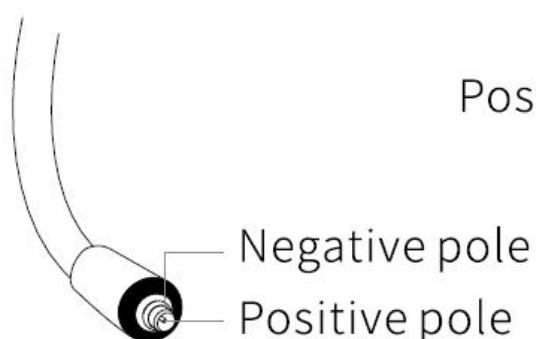

Instrukcje noszenia

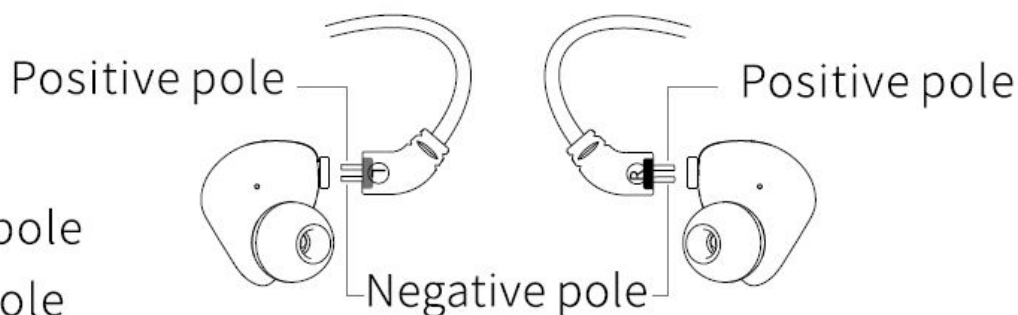
Aby zidentyfikować lewy i prawy kanał słuchawek i kabla: L = lewy kanał, R = prawy kanał. W przypadku braku znaków, znak „niebieski” oznacza lewy kanał, a znak „czerwony” oznacza prawy kanał.



W przypadku wymiany kabla innej marki, prosimy o wybranie kabla z tym samym typem złącza, co produkt. Dzięki temu jakość dźwięku i wrażenia słuchowe nie będą miały wpływu na jakość dźwięku.

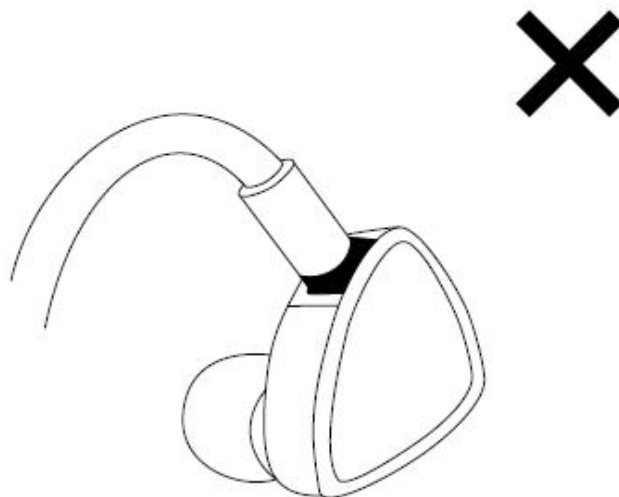
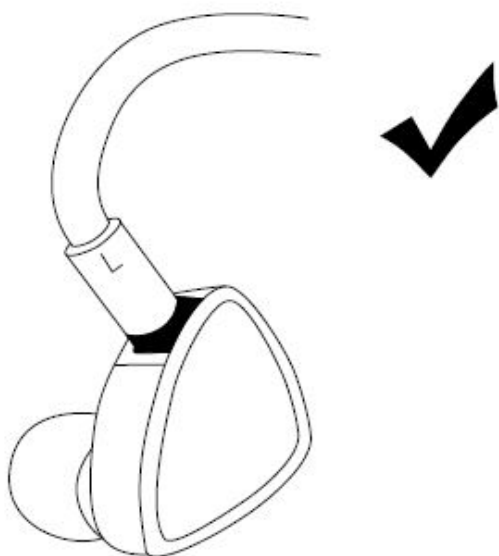


MMCX connector

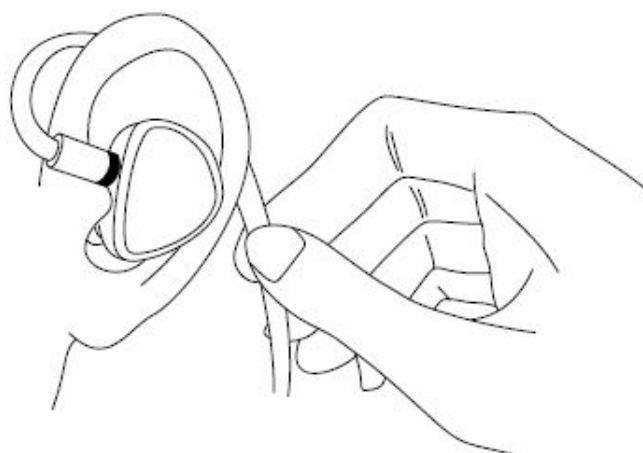
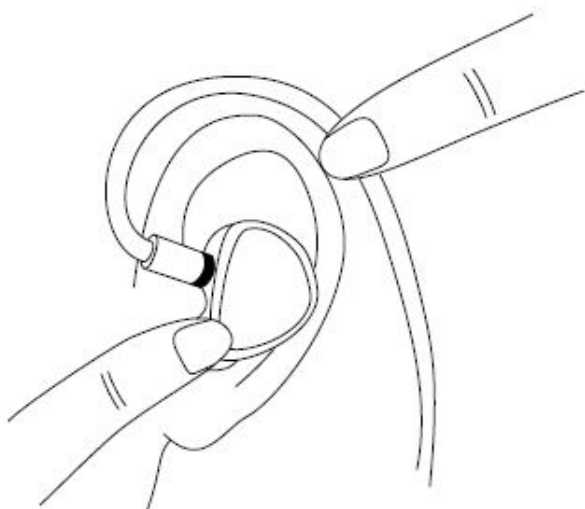


0.78mm 2-pin

Ten produkt ma konstrukcję zakładaną na ucho. Podczas instalowania kabla słuchawek upewnij się, że słuchawka i kabel mają kształt, który można owinąć wokół ucha, jak pokazano na poniższym rysunku.

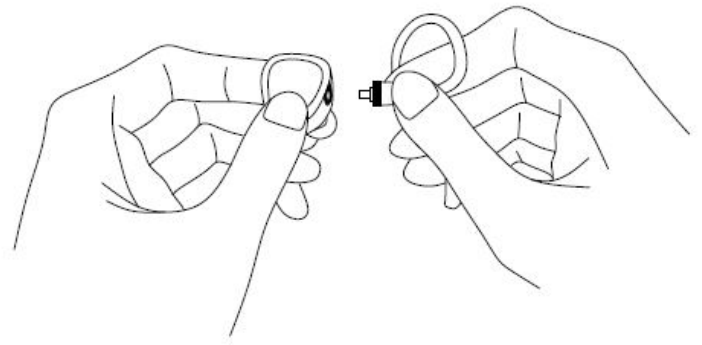
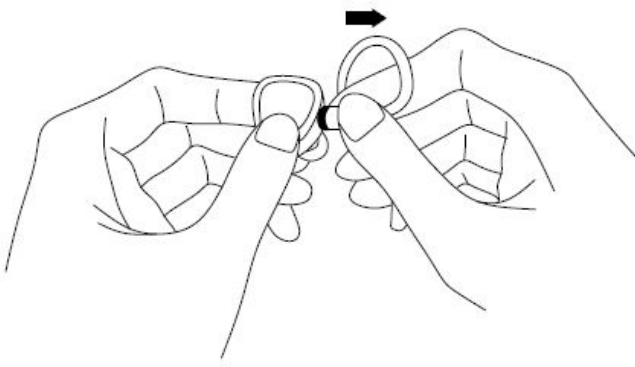


Podczas noszenia słuchawek, delikatnie obracaj i naciskaj jednostki zgodnie z kierunkiem pokazanym na obrazku. Po prawidłowym założeniu, umieść kabel słuchawek nad uchem i dopasuj słuchawki, aż poczujesz się komfortowo.

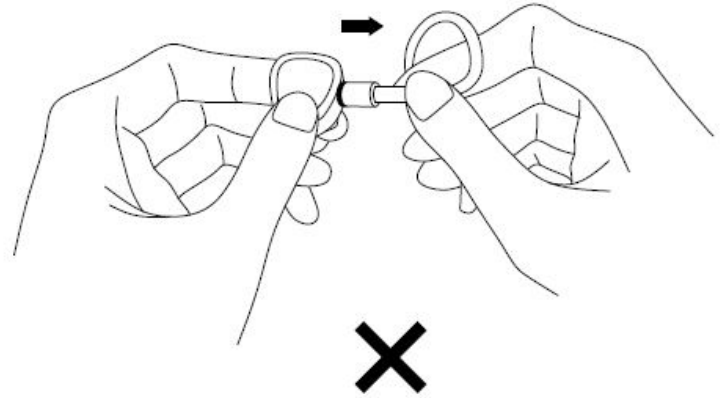
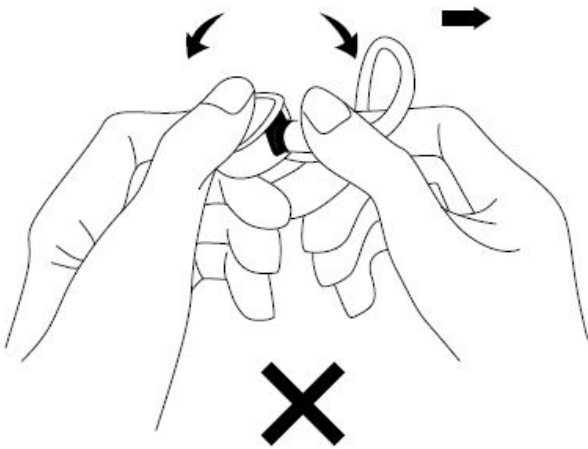


Podczas wyjmowania kabla słuchawek, przytrzymaj złącze kabla i słuchawkę mocno palcami. Trzymaj je w tej samej linii, a następnie rozłącz je. Możesz też użyć narzędzia wspomagającego MMCX, aby je odłączyć (sprawdź instrukcję narzędzia wspomagającego MMCX, aby dowiedzieć się, jak go używać). Pamiętaj, aby nie obracać kabla 0,78 mm z 2 pinami.





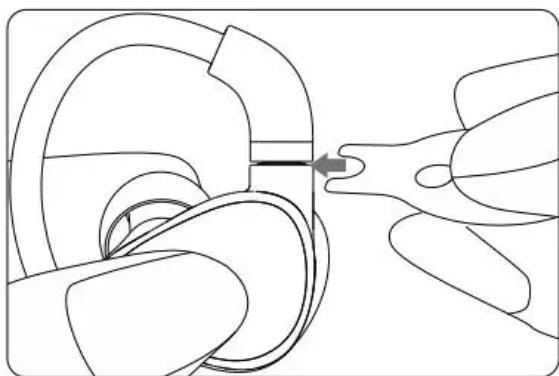

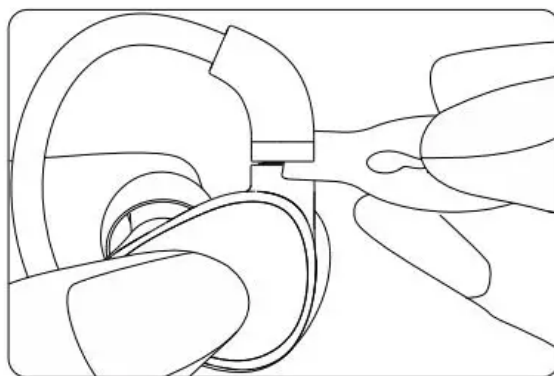

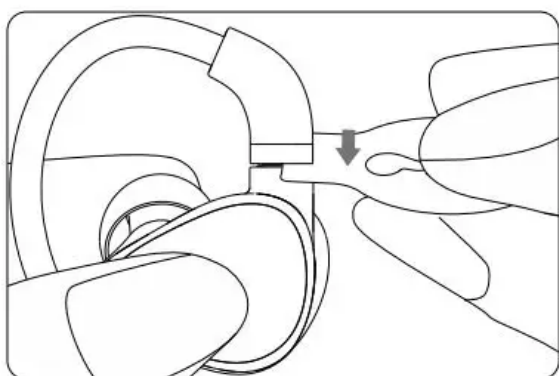
Jak korzystać z narzędzia MMCXAssist



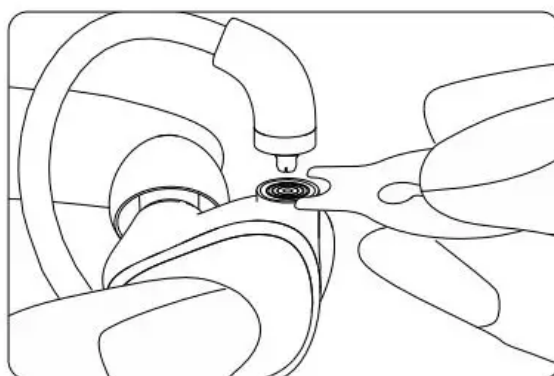
① Align the semi-circular indentation of the MMCX assist tool to the gap between the connector's male and female components.



② Ensure the tool is parallel to the gap and position it towards the gap between the connector's male and female components until it is in place.



③ Apply pressure by pressing down towards the other end of the tool.



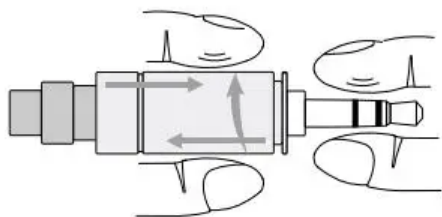
④ The earphone unit will then be detached from the earphone cable.

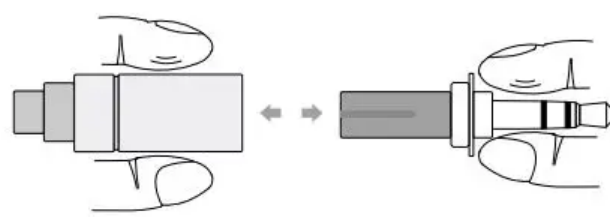

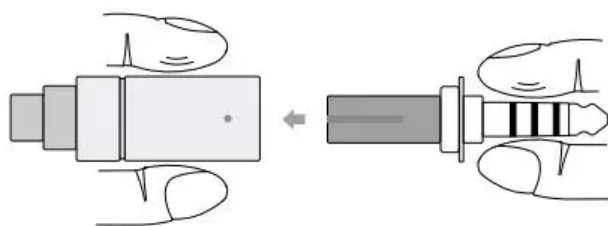
Jak wymienić wtyczkę słuchawek?



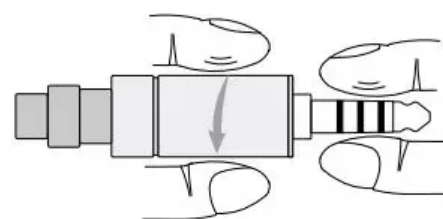
① Rotate the female end in a clockwise manner until the female end can be pushed front and back to unlock them.



② Pull the male end to detach the two connectors. (Objects that can generate greater friction like tissues or a strip of cloth can be used to help to detach.)



③ Align the male and female end of the connector, ensuring the notch of the male end is in parallel with the raised dot that's inside the female end. Plug the male end until it is in an appropriate position.



④ Rotate the female end in an anticlockwise manner until it is tight to lock them.
